Background

- October 2014: Federal Register Notice published (79 FR 61241) with plan to replace statewide data indicators used to determine a state's substantial conformity with titles IV-B and IV-E of the Social Security Act through the Child and Family Services Review (CFSR)
- May 2015: Federal Register Notice published (80 FR 27263) to correct some calculations and language used in October 2014 notice



Background

- After May 2015 Federal Register Notice: Identified additional technical errors in syntax and formulation of statewide data indicators
- October 2016: Published CFSR Technical Bulletin #9
 informing states of decision to limit use of CFSR
 statewide data indicators and national performance
 to context information for Round 3 of CFSRs due to
 additional time required to review, correct, and
 thoroughly test revised syntax



First Level Review: Federal staff from the Office of Data, Analysis, Research and Evaluation (ODARE) completed internal review, testing, and revisions

- Completed in-depth line-level review of all syntax
- Verified each step of indicator computation functions accurately and as designed
- Performed additional data quality tests to confirm integrity of population of child records eligible for analysis



Results of First Level Review completed May 2017

- Additional syntax revisions
- Changes to operationalization of measures
- New methods to screen and address data quality problems in the Adoption and Foster Care Analysis and Reporting System (AFCARS) and the National Child Abuse and Neglect Data System (NCANDS)



Second Level Review: An independent systematic review and verification of syntax

- Reviewed syntax for completeness, functionality on systems external to the Children's Bureau (CB)
- Performed reliability checks against performance indicators and state data profiles
- Performed line-level validity checks of SPSS and STATA syntax files for accurate task execution, data quality verification

Results of Second Level Review completed March 2018

- Confirmed revised syntax can validly and reliably develop source data files, perform data quality checks, calculate observed and risk-standardized performance
- Determined no errors that would cause inaccuracies in calculations
- Demonstrated ability for states and partner agencies to replicate syntax with several additional steps

Syntax Revisions

- All statewide data indicators impacted by revisions
- Some Data Quality Checks impacted by revisions
- Revisions range from minor refinements to more significant changes
- Description of all revisions by statewide data indicator and data quality checks provided as Federal Register supporting document



- Changes to more accurately capture all child maltreatment victimizations. Examples:
 - Use two years of NCANDS data for maltreatment in foster care
 - For states reporting child abuse victimization incident dates, require dates be reported for each substantiated or indicated maltreatment report to determine whether reports refer to same incident



- Changes to more accurately calculate number of days in foster care. Examples:
 - Use AFCARS Data Element "Date Child Was Discharged from Last Foster Care Episode"
 - Exclude AFCARS records with conflicting information
 - Use child's 18th birthday as date of discharge from foster care



- Changes to include all children in foster care a minimum of 12 months as of first day of 12-month reporting period for *Permanency in 12 months for* children in foster care 12 months or longer
- Changes to exclude children from all *Permanency in 12* months indicators when discharge from foster care is
 known and discharge reason is unknown



- Changes to more accurately count number of placement moves. Examples:
 - Apply correct adjustments to number of placement settings
 - Exclude placement moves when child not in foster care



- Changes to exclude some records from Data Quality Checks. Examples:
 - Some records missing information required to run check
 - Records for youth 18 years and older (with exception of three checks designed for older population)
 - Records for children who did not discharge from foster care when check pertains to population of children who exited care

Third Level Review:

Federal invitation to state child welfare agencies, partner organizations, and public to review, test, and provide comments on revised syntax to perform data quality checks and calculate observed performance on the statewide data indicators



2018 Federal Register Follow-Up

- Children's Bureau will review public comments to determine readiness to finalize revised syntax or potential need to make additional revisions
- Children's Bureau will issue Federal Register notice when revised syntax is finalized
- Notification will address applicable revisions and potential clarification needed to May 2015 Federal Register notice, and provide a summary and responses to public comments



2018 Federal Register Follow-Up

After syntax is finalized, CB will publish:

- Final revised syntax and supporting files to calculate data quality, observed performance, and riskstandardized performance for CFSR 3 statewide data indicators
- Revised performance results for all states
 - Revised national performance values

CFSR Round 3 State Data Profiles

2018 CFSR Round 3 State Data Profiles

- CB intends to publish data profiles for all states based on revised syntax, pending final verification during Federal Register comment period
- Goal is to provide all states opportunity to see state and national performance changes based on revised syntax, pending final verification
