CFSR Round 4 Is Underway!

The Round 4, Year 1, Child and Family Services Reviews (CFSRs) are underway. Kansas and Puerto Rico had the first CB-Led Reviews, in April and May, respectively. Several states have also kicked off State-Led Reviews, including Delaware, Indiana, and Massachusetts. Round 4 of the CFSRs is scheduled to run through federal fiscal year 2026.

The Capacity Building Center for States offers publications, tools, peer networking, and technical assistance to help child welfare agencies and their partners plan and implement all phases of CFSR Round 4, from Statewide Assessment planning through Program Improvement Plan (PIP) development and implementation.

APSR Process Integrated With CFSP

Over the last three Child and Family Services Plan (CFSP) submissions, the Children's Bureau (CB) has [intentionally integrated the CFSP/Annual Progress and Services Report \(APSR\) process with the CFSR](#). These federal planning, reporting, and monitoring processes require a state's assessment of the effectiveness of the child welfare system to achieve positive outcomes in the domains of safety, permanency, and well-being, as well as the statewide

routine functioning of seven systemic factors that support positive outcomes for the children and families served. States must submit the fourth APSR to the 2020–2024 CFSP to the CB by June 30, 2023.

New OSRI Course Released on E-Learning Academy

Recordings of the first two OSRI Virtual Trainings are now available to all Round 4 [E-Learning Academy](#) users in the State Catalog. The first, which focuses on Item 2 of the Onsite Review Instrument and Instructions (OSRI), is a recording of the online training presented on March 28, 2023. It focuses on critical elements to consider when rating Item 2, including safety vs. risk, appropriate safety-related services vs. services that should be considered in other items, and alternative caregiver arrangements.

The second training, which focuses on Item 5, is a recording of the training presented on May 17, 2023. It focuses on critical elements to consider when rating Item 5 of the OSRI, including instructions on how 15 out of the most recent 22 months should be calculated for children in foster care for CFSR purposes.

New CFSR Overview Video Released

A new CFSR Overview Video is now live on the Round 4 Resources page of the CFSR Information Portal. The video is in the [CFSR Round 4 Process](#) section of the Round 4 Resources page, and is publicly accessible to portal users even if they are not logged in.

The questions and their responses are organized by the seven CFSR outcome areas, with an additional “General Questions” category for questions related to the general application of the instrument as a whole and the instrument’s Face Sheet section.
